Abstract (public)

Exploitation activities within the GARPUR project aim at preparing the effective exploitation of the project results. Exploitation activities started from the first year of the project lifetime.

Exploitation activities are based on:

- Exploitation workshops (internal), organised once a year (4 workshops during the project lifetime),
- An exploitation plan, with several successive versions improving each year, and fed by the outputs of the corresponding exploitation workshop.

The present document, restricted to GARPUR partners and the European Commission, is the third version of the GARPUR exploitation plan. It is fed with the outputs of the first, second and third exploitation workshops, held in Nice in June 2014, June 2015 and June 2016.

For preparing the first exploitation workshop, a questionnaire was sent to all GARPUR partners. It invited them to

- describe the background they are bringing to the GARPUR project and indicate how it will be used;
- describe the foreground they expect to generate during the GARPUR project and how they intend to value and exploit it.

For preparing the second exploitation workshop, a questionnaire was sent to all GARPUR partners, focusing on the exploitation risks of the project.

For preparing the third exploitation workshop, a questionnaire was sent to all GARPUR partners, focusing on the mapping of GARPUR foreground.

From the conclusions of the series of three exploitation workshops, it appears that the final exploitation workshop (that will be held on [1-2 June 2017](#)) will be key to decide about the exploitation prospects of GARPUR.
